

What is the state's advice on handling head lice?

- ISBE follows the guidance of American Academy of Pediatrics
- Treat, do not exclude, for nits or live lice
- Student's civil rights to attend school (FAPE) may be violated if any exclusionary action is taken
- Parent should consult with pharmacist or health care provider
